FIRST: The name of the corporation is:

Mountaintop Detachment 1274, Marine Corps League, Inc.

SECOND: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law.

THIRD: The purpose or purposes for which the corporation is formed are as follows(type or print clearly):

To preserve the traditions and to promote the interest and perpetuate the history of the U.S. Marine Corps.

To participate and provide military colors, as requested. Publicly observing anniversaries of a historical nature, specifically those of particular interest to the U.S. Marine Corps and the U.S. Navv.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) or (4) of the Internal revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c0(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Upon dissolution of the corporation, any assets remaining will be used exclusively for exempt purposes, and shall be distributed to the national headquarters for charitable purposes (which National Headquarters is a special tax-exempt entity under section 501(c)(4) of the IRC).
